May 4, 7:45 a.m. - Little Spring Day at Chigger Holler

Note that this is a Sunday field trip. Anyone who would like to carpool from Roanoke can meet at Tanglewood Mall under the big sign at 7:00 a.m.. If you're driving yourself down and need directions, contact Tim and Alyce. The address is 681 Edgewood Farm Lane, Wirtz, VA 24184. (Keep an eye out for Eurasian Collared-Doves as you pass the Burnt Chimney Elementary School on your way.) If you're not birded out from Big Spring Day, join Tim and Alyce Quinn (719-0109), twoquinns@yahoo.com at their house in Burnt Chimney in Franklin County the following day for a morning of looking for spring migrants and resident birds. They have a variety of habitats including woodland trails, a pond, scrub and open fields, and their property list includes over 130 species. Wear sturdy shoes as the footing is rather uneven. If you don't want to hike, there's a big deck and lots of chairs to bird from the yard. If you'd like to stay for lunch, bring a dish to share.

May 10th - Warbler Road

Saturday at 7:00 a.m. Meet leaders Tim and Alyce Quinn (719-0109) near the Bojangles at Botetourt Commons in Daleville. We will bird a series of forest service roads between the Blue Ridge Parkway and Arcadia in search of warblers and other Neotropical migrants. This trip usually lasts into the afternoon so bring drinks, snacks and a lunch. Dress in layers and be prepared to carpool as pull-offs are limited. Important: we are going to try something new and bird from the top down, starting at the Sunset Field overlook on the Parkway; so if you're planning to catch up with the group along the route somewhere, take that into consideration.

May 11th - Mother's Day Birding

Sunday at 8AM join Laura Beltran (269-569-5791) for a walk on the Mill Mountain Star Trail to look for spring migrants. We will start at the trail head off of Riverland Road, walking up the mountain and then back for about a 2 mile walk. The trailhead is close to the intersection of Riverland Road and Garden City Blvd.

May 14th - Second Wednesday Walk with Laura Beltran

8:30 a.m. with Laura Beltran (269-569-5791). We will walk around Greenfield Lake in Botetourt County and search for waterfowl and songbirds. The walk will be mostly flat walking for about 1 1/2 miles. Meet at the second dirt parking lot (off of International Parkway) on the right across the road from the lake.

May 17th - Natural Bridge birding with Wes Teets - We will meet at 7AM at Botetourt Commons (in front of Bo Jangles) and carpool up to the Natural Bridge Hotel. Our tour guide, Wes Teets, will meet us in the hotel lobby at 7:45AM. The hotel bus will take us to various birding spots in the vicinity. Wear waterproof shoes and bring rain gear and/or sun screen as this field trip will take place rain or shine. Be aware of ticks, so bring spray. After the bus brings us back to the hotel (late morning) we can visit the Natural Bridge with a 10% club discount. At that time the deli will be open if we are hungry and the Summer House restaurant will be open at the bridge. Bluebird Box Building Workshop

In March, Alyce Quinn, Allen Austin and Dick Hendrix led a workshop showing members of the Town and Country Garden Club how to build bluebird boxes. Participants' skills ranged from one who brought all her own tools and appeared to have some woodworking experience to one who allegedly had never used a screwdriver in her life! The ladies (and one gent) seemed to have a great time and everyone got to take home a completed box. A few even purchased a kit so they could build another box at home.

Baby Bird Rehab Supplies still needed

All items are used for rehabbing injured or orphaned wild birds. If you need a tax deductible receipt one will be provided. Thanks for your help!

- Paper towels & tissues (baby birds poop!) and old but clean towels
- Cat or dog carriers, bird cages
- Sugar, Suet cakes, small bags of seed, Dove Mix (found only at Petco)
- Grocery store items; powdered egg whites, white sugar, peanut butter, jam or pure fruit jelly (any berry or grape), Gerber chicken and gravy (only) baby food
- Cleaning supplies; bleach, sponges and tall kitchen bags (use 1 bag a day), unused spray bottles
- For the outdoor bird cages; tree bark (large strips), wooden dowels, fiberglass screen, shade cloth, logs, bags of landscape pebbles, ¼" hardware cloth.
- Do you have fruit trees or berries on your property and would like to share with the rehab birds?
- Also if you find/have Gypsy Moth cocoons, call me at (342-4890) Thanks! Maureen



In the current Bylaws it was unclear as to who can vote at Board meetings besides the executive committee officers. As a chapter of the Virginia Society of Ornithology, we have revised the Bylaws to also include a Board of Directors with voting rights. Other changes include many clarifications on how the club operates and adding non-discriminatory legal clauses. We did not change our mission or purpose of the Club and the membership dues were kept the same.

The revised edition of the Bylaws is on the following pages for club members to consider before a general membership vote to approve them is done at the beginning of the September meeting. Please send your comments and suggestions in writing to Linda Cory, the Bylaws Chairperson (LCORY50@juno.com) prior to the May meeting. We will have a brief discussion at that meeting as well as the September meeting before a vote is called. Many thanks go to the Bylaws committee for their hard work, time and thoughtful effort; Bylaws Committee Chair, Linda Cory and Committee Members, Maureen Eiger and Carol Whiteside. This document had a thorough review and input of the entire Board. We hope you will approve of the revisions and the club will be prepared for the next 50 years. Thank you for your support.

Proposed New Bylaws for the Roanoke Valley Bird Club

Roanoke Valley Bird Club Organized in 1957 Bylaws (Revised 2014)

ARTICLE I - Name

Name: The name of this organization shall be Roanoke Valley Bird Club, referred to herein as the Club, and is organized as a constituent local chapter of the Virginia Society of Ornithology.

ARTICLE II - Purpose

Purpose: The object of the Club shall be to educate and promote interest about birds and conservation, to organize bird study field trips and bird census, and other avian related projects.

ARTICLE III – Quorum

Quorum: A quorum is the minimum number of members who must be present at the meetings of a deliberative assembly, for business to be legally transacted. Before the presiding officer calls a meeting to order, it is his duty to determine that a quorum is present. If a quorum is not present, the chair waits until there is one, or until, after a reasonable time, there appears to be no prospect that a quorum will assemble. If a quorum cannot be obtained, the chair calls the meeting to order, announces the absence of a quorum, and entertains a motion to adjourn. Voting can only be conducted in person.

ARTICLE IV – Membership and Dues

Section 1. The membership shall consist of all persons desiring membership and having paid the required dues.

Section 2. Classes: There shall be five membership classes: Individual, Family (defined as two votes), Student (defined as any full time student), Sustaining, and Life (defined as being exempt from the payment of dues, after the recommendation by majority vote of the Board of Directors).

Section 3. Dues: All annual dues are payable September 1. Dues will not be prorated; however, anyone joining the Club June 1 or later will have their dues applied to the following annual year. Members who have not paid their dues by the November meeting shall be dropped as members in good standing of the Club, and will not be eligible to vote or receive any Club publications.

ARTICLE V – Membership Meetings

Section 1. Membership Meetings: The Club shall hold at least nine meetings each year, but shall not be restricted to this number, on the second Monday of each month from September through May, unless otherwise ordered by the Board of Directors.

Section 2. Notification: All members in good standing shall be notified of all meetings.

Section 3. September Meeting: A Nominating Committee shall be elected.

Section 4. October Meeting: The Slate of Officers and Directors shall be presented by the Nominating Committee.

Section 5. November Annual Business Meeting: The purpose of this meeting shall be the annual election, receive annual reports, and any other business transactions. Additional nominations may be taken from the floor by any member in good standing.

Section 6. Voting and Quorum: Only members in good standing are entitled to vote. Twenty-five members or twenty percent of the members entitled to vote, whichever shall be less, shall constitute a quorum at any meeting of the membership. Less than a quorum may adjourn the meeting to a fixed time and place, no further notice of any adjourned meeting being required.

Section 7. Any financial requests shall be referred to the Board of Directors for consideration.

ARTICLE VI – Officers and Directors

Section 1. Officers and Duties: The Officers of the Club shall be a President, First Vice-President of Programs, Second Vice-President of Membership, Secretary, Treasurer, and a number of, not less than four or more than eight, Directors. Together the Officers and Directors shall be known as the Board of Directors, referred to herein as the Board, and shall perform the duties prescribed by these Bylaws and by the parliamentary authority adopted by the Club. In the absence of the president, the presiding officer shall be ordered by the sequence of the officers listed.

Section 2. Elections, Voting and Terms: The Officers and Directors shall be elected during the November business meeting and shall begin their terms on January 1 following the election, shall serve for one year, and shall be eligible for re-election. In the event of more than one candidate for any office, voting shall be by secret ballot. Any candidate receiving a majority of the votes shall be declared elected. Only members in good standing may hold office and shall be eligible to vote as a member of the Board.

Section 3. Vacancies: Board vacancies may be filled by majority vote of the Board for the unexpired term only.

ARTICLE VII - Board of Directors

Section 1. Board Composition and Duties: The Officers of the Club, including the Directors, shall constitute the Board of Directors. The Board shall have general supervision of the affairs of the Club, make recommendations and reports to the Club, and is subject to the orders of the Club. The Board shall supervise the finances of the Club. It shall be the duty of the Board to take the initiative in determining the policies and planning of the activities of the Club. Board members are unpaid volunteers.

Section 2. Code of Conduct: The Board of Directors agrees to operate the Club in a manner that is in the best interest of the Club. Verbal abuse towards, or deliberately provoking another Club member is not acceptable. They shall refrain from illegal activities, conduct business in a professional manner that respects all Club members, and shall not do anything which is likely to intimidate, offend, insult, humiliate or discriminate against any other person on the ground(s) of gender, race, disability, age, religious or political belief, sexual orientation, social background, ethnic origin, language, marital or civil partnership status. If a Board member does not abide by this conduct he/she shall be removed from office by a majority vote of the Board.

Section 3. Meetings: There shall be a minimum of three Board meetings a year. Meetings can be called by the President or at the request of three or more members of the Board. Any member of the Club may attend a Board meeting by formal request to the President.

Section 4. Voting and Quorum: Only Officers and Directors in good standing shall be eligible to vote. The majority of the Board of Directors shall constitute a quorum at any meeting of the Board. Less than a quorum may adjourn the meeting to a fixed time and place, no further notice of any adjourned meeting being required.

ARTICLE VIII – Committees

Section 1. The President, with the approval of the Board, shall appoint all Committees except the Nominating Committee. A majority of any committee shall constitute a quorum of that committee and committee business need not be conducted in person. All committees shall be subject to the call of their respective chairmen, and the chairman shall be responsible for reporting all of their committee business and expenditures to the Board of Directors.

Section 2. Nominating Committee: A Nominating Committee, consisting of three or more members in good standing, shall be elected at the September membership meeting. This Committee shall research and prepare a slate of one nominee for each officer and director position to serve for the succeeding year and shall make their report at the October membership meeting. The membership shall receive written notification of the slate prior to the November election.

ARTICLE IX - Parliamentary Authority

Roberts Rules of Order Newly Revised shall govern the Club in all cases to which they are applicable and in which they are not inconsistent with these Bylaws and any special rules of order the Club may adopt.

ARTICLE X - Amendment of Bylaws

The Bylaws may be amended by the Board of Directors by a majority vote. The Club membership is then notified at least thirty (30) days in advance of the proposed amendment(s). It is ratified by a majority vote of the Club members in attendance at any membership meeting.

ARTICLE XI - Indemnity

Members of the Board of Directors and members of committees shall be indemnified by the Club against liabilities, fines, penalties, and claims imposed upon or asserted against the member in connection therewith.

The undersigned, Kent E. Davis, President of the Roanoke Valley Bird Club, hereby certifies that the attached is a true, correct and complete copy of the Bylaws adopted by the members of the Roanoke Valley Bird Club at a meeting held in Roanoke, Virginia, and supersedes any other Bylaws of the Club.

IT'S NESTING SEASON AND FLEDGLING BIRDS NEED YOUR HELP

- ❖ **Keep your cat indoors and encourage others to do the same.** Cats can get used to an indoor lifestyle. Cats that are allowed to roam outdoors can encounter feral cats and are more likely to catch a disease.
- ❖ **Identify your cat.** Use a collar and tag or microchip your cat in case it gets lost.
- ❖ **Don't feed unknown cats without making a commitment to finding them a permanent home.** Feeding stray cats will only establish their presence and lead to rapid growth in their numbers. Instead take them to a local animal shelter where they have the chance to be adopted.
- ❖ **Spay or neuter your cat as early as eight weeks of age.**
- ❖ **Never abandon cats.** This is illegal and cruel behavior. Instead take the cat to an animal shelter where it has a chance of being adopted.
- ❖ **Support laws that prevent cats from roaming.**
- ❖ **If you are unwilling to keep your cat indoors, do not attract birds to your yard by putting out bird feeders, bird houses and bird baths.**

The American Bird Conservancy (ABC) has published a new report, Impacts of Feral and Free-ranging Cats on Bird Species of Conservation Concern: A Five-State Review of New York, New Jersey, Florida, California, and Hawaii, which, for the first time, analyzes the effects that cats are having on some of America's most at-risk bird species at cat predation hotspots. The five-state review illuminates troubling threats to endangered species such as the Florida Scrub-Jay, Piping Plover, and Hawaiian Petrel, and other key birds such as the Painted Bunting, Least Tern, and Black Rail. BIRD TOPICS

BIRD FEET

Birds have an amazing foot that is much different than ours. Most people think that a bird's knee bends backwards, but in fact what we think looks like a knee is actually the bird's ankle / heel joint. The knee is hidden under feathers close to the bird's body. Since everything under the ankle is the foot, it is easy to see that a bird actually walks on its toes. Another name for a bird's toe is a digit. When comparing a bird's digit with our toes, the first digit would be our big toe. The second digit would be the next toe and so on. Birds are missing the fifth digit, or our little toe. In fact, some birds have only three toes, and the Ostrich has only two.

A bird's toes give a bird the ability to grasp a branch and not fall off due to the action of tendons. These tendons are pulled tight when a bird sits on a perch. The tendons are attached to muscles above the bird's heel-the joint that looks like a backward knee to us. The particular tendons are called flexor tendons and they run down the backs of the legs and to the tips of the toes. When the bird sits, the tendons pull on the toes and close them tightly, like a fist. This automatic grip is strong enough to allow the bird to sleep while perching. The same mechanism is at work when a raptor captures an animal, serving to clench the talons and pierce the prey on impact. Woodpeckers are slightly different in that instead of three toes facing forward and one facing back, they have two toes forward and two back. This allow for greater support in the way they forage for food. Along with this toe arrangement they also have stiff tail feathers that add even more support.

So, why don't birds feet freeze to the bird bath or on a metal perch of a bird feeder? This is due to the circulatory system of birds that help maintain temperatures. Birds have a cluster of veins and arteries that redirects blood flow so as to reduce heat loss. This cluster is referred to as a "heat exchanger." Warm blood flowing through arteries would normally flow into the bird's legs before returning to the heart. When the legs are cold the artery in each upper leg constricts and forces blood to flow through the heat exchanger. Without going into a lot of detail, the cold blood rubs against the warm blood and this allows the blood to flow to the bird's toes without much heat loss to the environment. This type of blood flow arrangement saves heat and actually helps the birds keep a fairly efficient insulation against the cold. There's not a lot of active tissue in a bird foot. The muscles are mostly located in the thigh region, and so that leaves the mostly hollow bone, skin and some connective tissue. So, the bird feet do not require a high amount of blood flow. Nevertheless, this kind of blood flow pattern is argued to provide birds and mammals with the ideal solution: blood still flows and provides the tissues with nutrients and oxygen, while not dumping precious body heat to the environment. The tissues themselves can handle being cold, provided they do not actually reach temperatures below freezing.

BIRD WORD ANSWER – Cosmopolitan species: This is any species that breeds over much of the globe, including both the Old World and the New World, as opposed to most other species that are confined to just one or two of the world's regions.
